### **SIZE REQUIREMENTS (HxW):**

Minimum size **16x20**; Maximum size **40x30** inches

**PLEASE - WIDTH NO WIDER THAN 30 inches**

**This is a Juried exhibit. You need to include a jpg image of the artwork. The jpg image must be no smaller than 400 and no larger than 1000 PX on either side**

**Images must be labeled using the following format:**

**Other Call Information:**

- Please show your art to the Coordinator before leaving the venue. Artwork hanging system will be checked for sturdiness.
- Please be sure to sign your art in and out prior to leaving the venue.
- Attach your contact information and the title of the artwork to the back of your piece(s).
- It is the responsibility of the artist to ensure State sales tax is paid on each work sold, not CAS.
- If you would like to gain experience hanging an exhibit, please let the exhibit coordinator know you would like to volunteer.
- Creative Arts Society receives a **15% commission on all art sales** made at our venues. The commission is to be paid within 15 days from the date of the sale. It is calculated based on the price of the artwork before sales tax and any credit card fees. Commission payments can be made online through Paypal or by mailing a check.
